## Why?

Financial companies choose how they share your personal information. Federal law gives consumers the right to limit some but not all sharing. Federal law also requires us to tell you how we collect, share, and protect your personal information. Please read this notice carefully to understand what we do.

### What?

The types of personal information we collect and share depend on the product or service you have with us. This information can include:

- Social Security number
- Driver's license number
- Date of birth
- Account numbers
- Financial status
- Tax status

#### How?

All financial companies need to share clients' personal information to run their everyday business. In the section below, we list the reasons financial companies can share their clients' personal information; the reasons Jim Saulnier & Associates, LLC chooses to share; and whether you can limit this sharing.

What happens when I limit sharing for an account I hold jointly with someone else?	This does not apply, because we do not share your information for any purposes that limitations could apply (see item immediately above).
Definitions	
Affiliates	Companies related by common ownership or control. They can be financial and nonfinancial companies.  Jim Saulnier & Associates, LLC is affiliated with Jim Saulnier, LLC
Nonaffiliates	Jim Saulnier Tax Planning, LLC and 430 Whedbee, LLC.  Companies not related by common ownership or control. They can be financial and nonfinancial companies.  Jim Saulnier & Associates, LLC does not share with nonaffiliates
Joint marketing	A formal agreement between nonaffiliated financial companies that together market financial products or services to you.  Jim Saulnier & Associates, LLC has no such agreements
